TRANSFER OF EQUITY SHARES TO INVESTOR EDUCATION & PROTECTION FUND

This Notice is published pursuant to the provisions of the Companies Act, 2013 read with the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016 ("the Rules") notified by the Ministry of Corporate Affairs effective 7th September, 2016 and relevant amendments notified thereafter from time to time by the Ministry of Corporate Affairs. The Rules, inter alia, provide for transfer of all shares in respect of which dividend has not been paid or claimed by the shareholders for seven consecutive years to the Investor Education and Protection Fund (IEPF) set up by the Central Government.

Shareholders who have not claimed the dividend for seven years beginning from 2018-19 are requested to contact **The Vice President (Finance & Accounts), Stanes Amalgamated Estates Limited, 8/23-24, Race Course Road, Coimbatore- 641018** and send the undertaking (available on the website of the Company) duly filled in and signed along with a self-attested copy of your PAN card, copy of address proof, a cancelled cheque and signature attestation letter from the Bank Manager by **19th September 2026** to have their dividend claimed and avoid transfer of their shares to IEPF account, failing which the Company will proceed to transfer the dividend pertaining to 2018-19 and the underlying equity shares, registered in such share holders name to the credit of the IEPF account of the IEPF Authority, in accordance with the said Rule, without any further notice.

It may also be noted that the shares transferred to IEPF, including all benefits accruing on such shares, if any, can be claimed back from the IEPF Authority after following the procedure prescribed under the Rules.
